Propositions

Proposal One, an Amendment

Amendment to Allow Olympic Sports Complex in Essex County on State Forest Preserve Land

Allows skiing and related trail facilities on state forest preserve land. The site is 1,039 acres. Requires State to add 2,500 acres of new forest land in Adirondack Park.

A "Yes" vote authorizes new ski trails and related facilities in the Adirondack Forest Preserve.

A "No" vote does not authorize this use.

Propuesta numero uno, una enmienda

Enmienda para Permitir Complejo Olimpico de Deportes En el Condado de Essex en Tierra de Reserva Forestal Estatal Preservar la tierra

Permite el esquí e instalaciones relacionadas de pistas en tierra de reserva forestal estatal. El sitio es de 1,039 acres. Requiere que el Estado añada 2,500 acres de nueva tierra forestal en el Parque Adirondack.
